Susan Marie Purcell Gaffney Miller, age 80, of Lake Mills, passed away peacefully, surrounded by her family on Tuesday, July 11, 2023 at the Lake Mills Care Center.

Susan Marie Purcell was born on April 3, 1943 at Irish Hospital in Forest City, Iowa to Glen and Marcella (Brue) Purcell. She was baptized and confirmed at the Fertile Lutheran Church, attended school in Fertile, and graduated from Fertile High School in 1961. She enjoyed all sports, music, band, plays, etc. and was nominated as Fertile Band Queen at the Band Festival in Mason City.

She went on to attend the University of Iowa her freshman year, where she was an outstanding student in both fencing and bowling class, returning to Mason City for summer school. Sue ultimately graduated from Mason City Junior College (NIACC) in 1963.

On September 7, 1963, Sue was married to Thomas Hayes Gaffney at the Fertile Lutheran Church, and they had two children: Jamie Sue and John Thomas. The family lived in Mason City, Clear Lake, Oelwein, Fairfield, Ottumwa and Waterloo, Iowa before moving to Forest City, Iowa in 1968. Tom was the Director of Corporate Credit at Winnebago Industries before dying on March 5, 1976 from a cerebral aneurysm.

Sue was united in marriage with Dennis K. "Deke" Miller on July 22, 1978 at Immanuel Lutheran Church in Forest City, Iowa. They raised their children in Forest City before moving to Lake Mills (Rice Lake) in March of 2000.

Sue worked at Dr. R.W. Hynes dental office as a dental assistant for 13 years and then at Winnebago Industries as a parts administrator for 23 years before retiring in 2007. She is a member of Salem Lutheran Church in Lake Mills, and Rice Lake Golf & Country Club. She enjoyed her home, and watching the birds and wildlife. Other interests include cooking and entertaining family and friends, golf and her bridge club in Forest City for 30-some years, working in her yard and hosta gardens, and decorating her home for each season and holiday.

Deke and Sue loved to travel, especially enjoying the three Caribbean cruises and four trips to Hawaii with her siblings. They also owned a weekend cottage in Waterville, Minnesota for 19 years where they enjoyed all the lake activities with family and friends.
